

Longfield Raffle- Terms and Conditions

Longfield Community Hospice raffle is licensed by the Gambling Commission under the Gambling Act 2005 (www.gamblingcommission.gov.uk). Responsible Persons: Louise Cook at Longfield Community Hospice, Burleigh Lane, Minchinhampton, Glos. GL5 2PQ registered charity number 298627.

All profits from any raffles conducted by Longfield are used to fund the work of Longfield's free care and support to patients with life-limiting illnesses, their family members and carers.

By taking part in this raffle you agree to the following terms and conditions. Any entry not complying with these terms and conditions will be invalid. Longfield's decisions pursuant to these terms and conditions shall be final and binding.

- 1. You represent and agree that you are:
 - a. Over 18 years of age
 - b. You are a resident of Great Britain.
 - c. You will not buy or purport to buy an entry in this raffle on behalf of anybody under the age of 18.
 - d. You will provide accurate entry information, including your name and address
 - e. You agree that you shall not be entitled to receive any prize if you are unable to substantiate to the Promoter the above.
- 2. Entry is open to all residents of Great Britain (including staff and volunteers of Longfield) but excludes: Louise Cook from Longfield as promoters of the raffle.
- 3. Entry cost is £1 per ticket, payable in advance, by one of the methods permitted within the entry form. Payment by credit card is strictly prohibited. Entries may not be sold to or by anyone less than 18 years of age. Each ticket represents one entry only.

- 4. Longfield is not liable for any lost, stolen, delayed, incomplete or illegible entries, or entries that reach us after the closing date, or for any delay in bank payments. Proof of posting is not proof of delivery.
- 5. Longfield may (without giving any reason or notice, at its absolute discretion) decline to accept an entry.

The draw is conducted on **3 August 2024 at 3.30pm** The closing date for online or postal entries will be Midnight on **Wednesday 31st July 2024 or in person 3pm on 3rd August 2024.**The draw will take place at Longfield, Burleigh Lane, Minchinhampton, Glos GL5 2PQ. All tickets will be put into a secure container and picked out by an independent person with witnesses. The results of the draw are final.

There are no alternatives to any of the prizes.
