# How does Write a Will Month work?

From 1 - 30 September, when you make or update your Will by following the simple steps below, all donations will go to Longfield Community Hospice.

- **£90 donation for a single basic Will**
- **£160 donation for a pair of basic 'mirror' Wills**

Step 1: Select your preferred solicitor from the list below and give them a call directly to arrange an appointment, quoting "Longfield Community Hospice September Write a Will Month".

Step 2: Make your donation at the appointment by cheque made payable to 'Longfield', online at [www.longfield.org.uk/write-a-will](http://www.longfield.org.uk/write-a-will) or via telephone. An email receipt confirming the donation can be taken along to your appointment.

Step 3: Download the Will planning pack from [longfield.org.uk/write-a-will](http://longfield.org.uk/write-a-will) or request a copy from Longfield on 01453 886868. This will help you think about all the information the solicitor will need from you at the meeting, so you can go along prepared.

# Why should you make a Will or update an existing Will?

Writing a Will is something many people keep putting off, always thinking there will be time later to do it. But there are lots of important reasons to make your Will and the sooner it's done, the sooner you can relax in the knowledge that everything's in order.

- If you die without a Will, there are certain rules which dictate how the money, property, or possessions should be allocated. This may not be the way that you would have wished your money and possessions to be distributed.
- Unmarried partners and partners who have not registered a civil partnership cannot inherit from each other unless there is a Will, so the death of one partner may create serious financial problems for the remaining partner.



- If your circumstances have changed, it's important that you make a Will to ensure that your money and possessions are distributed according to your wishes. For example, if you have separated and your ex-partner now lives with someone else, you may want to change your Will. If you are married or enter into a registered civil partnership, this will make any previous Will you have made invalid.

- If you have children, you will need to make a Will so that arrangements for the children can be made if either one or both parents die.
- It may be possible to reduce the amount of tax payable on the inheritance if advice is taken in advance and a Will is made.

**A gift in your Will, however large or small, whenever the time is right for you, will help Longfield to continue to care. After your family and friends have been remembered, it gives you the opportunity to leave a gift to Longfield Community Hospice. This gift can have an impact on people's lives for years to come.**
